

ADMISSIONS POLICY



SUMMARY

All Schools are legally required to have an Admissions Policy that gives a clear account of their entry procedures. They are expected to apply them fairly and consistently. The policy is available on the School's website and on request from the Admissions Office within each school in The Group.

GENERAL

The Stowe Group comprises of four schools - Stowe School, Ashfold School, Swanbourne House School and Winchester House School. All four schools provide co-educational independent school education for pupils.

Stowe School provides education for children from ages 13 to 18 and currently educates 890 pupils. Ashfold School provides education for children from ages 3 to 13 and educates 223 pupil. Swanbourne House School provides education for children from ages 3 to 13 and educates 295 pupils. Winchester House School provides education for children from ages 3 to 13 and educates 342 pupils.

Deciding on the right school for your child is very important, and we believe that a personal visit is invaluable. Each school holds a number of Open Mornings which give a general introduction to the school; details of these mornings are published on our schools' websites, alongside information about each school's educational offer.

STOWE SCHOOL

ADMISSIONS PROCEDURES & CRITERIA

General	<p>Families interested in Stowe need to register for a place. Parents are required to complete a Registration Form which is available on the School's website and to pay the Registration Fee.</p> <p>Parents are encouraged to attend one of the School's Open Mornings or are welcome to arrange a tour of the School at another time.</p> <p>Parents should contact the Admissions Office for further details.</p>
Registration Fee	<p>£295 (excl. VAT) non-refundable Registration Fee. There is no Registration Fee for children joining from The Stowe Group Schools.</p>

Entry Points	The following procedures apply at each of the main points of entry at 13+ (Year 9) and 16+ (Year 12) and also to candidates for vacancies that may arise in Year 10 (14+).
Procedure	<p>The School's Admissions procedure has three elements:</p> <ol style="list-style-type: none"> 1. Academic entrance assessments. 2. Interviews which take place during the child's individual visit for Third Form candidates or Entry Day for Sixth Form candidates. 3. References and confidential information disclosure.
Entrance Assessments	<p>13+ /Year 9 Entry</p> <p><i>CAT4 Tests</i> All 13+ candidates will sit a CAT4 Test for Stowe. Candidates sit the tests for Stowe in Year 6 (or later if their application comes later).</p> <p><i>International Pupils</i> Candidates who live overseas and for whom English is not their first language, will be required to take the UKiset test before an offer of a place can be made. Native English speakers, or those who are fluent in English, will be required to sit the ISEB Pre-Tests depending on their personal circumstances.</p> <p><i>Stowe Group Pupils</i> Children joining us from our Prep Schools within The Stowe Group are required to meet our Entry Criteria, progression to Stowe is not automatic. However, pupils from Ashfold School, Swanbourne House School and Winchester House School are not required to sit CAT4 test as their CAT4 or MidYIS tests from their routine academic programme at their prep school will be shared with Stowe.</p> <p>14+ /Year 10 Entry Candidates must undergo interviews and provide the last two reports from their current school. Fourth Form applicants are required to take CAT4 tests either at Stowe, with their current school or under the supervision of a Lawyer.</p> <p>16+ /Year 12 Entry All candidates must complete the online CAT4 or UKiset tests by October. Candidates are also required to attend an Entry Day in early November when they will take an English Essay paper and have a pastoral interview with a Houseparent. Those considering a maths-based subject at A level are also required to sit a Maths paper. Offers of places are made on 1 December and are conditional on candidates gaining the required GCSE/IGCSE (or equivalent examination) results. Candidates will be informed of the applicable grade requirements. Pupils who live overseas and for whom English is not their first language will be required to take a written English paper (set by Stowe) before an offer of a place can be made.</p>

<p>Interviews</p>	<p>In addition to the entrance assessments set out above, all candidates will be interviewed. These are of two kinds:</p> <ol style="list-style-type: none"> 1. General interview: in all cases there will be a general interview to explore the candidate's interests, attitude to school, personal qualities, ability to contribute to the School community, suitability for boarding (where appropriate), support available at home and any relevant connection with the School. 2. Option interview: at Scholarship Entry Days there will be an 'option interview' to explore a candidate's ability in a particular subject. For certain option subjects (such as Art, Design etc.) candidates will be asked to submit samples of their work, or they will be asked to audition (e.g. for Music or Drama).
<p>Confidential Reference</p>	<p>The Head of the candidate's current school will be asked to provide a written reference and a report as to the candidate's academic ability, attitude and behaviour, involvement in the School community, talents and interest, and any other special circumstances such as special education needs or disability.</p> <p>Parents are asked to give full disclosure to the School about their child on a 'Confidential Information Form' to give the School a full picture of the child's emotional, physical and educational needs. The disclosure of confidential information includes, but is not limited to:</p> <ol style="list-style-type: none"> 1. Any medical condition, health problem or allergy affecting your child. 2. Any learning difficulty, disability, or special educational need of your child, as well as any behavioural, emotional and/or social difficulty of your child. This will enable the School to consider any adjustments that it may need to make to assist your child to partake in the School's Admissions procedure or when your child enters the School. <p>We also ask you to disclose any welfare concerns relating to your child that the School should be aware of, including:</p> <ol style="list-style-type: none"> 1. Self-harming behaviour and/or eating disorder. 2. Any incidents of bullying. 3. Mental Health issues such as ADHD, anxiety, panic attacks, OCD, depression, suicidal thoughts. 4. Referrals to Child Social Services and/or Court Orders.
<p>Entrance Criteria</p>	<p>Our Entrance Criteria is as follows:</p> <ol style="list-style-type: none"> 1. Success in the relevant entrance assessments and/or achieving the required GCSE grades, as appropriate. 2. A satisfactory interview. 3. A positive confidential reference or report from the candidate's present school (if applicable).

	<p>4. Full disclosure of confidential information.</p> <p>5. Commitment to the School's ethos as described in the School's aims.</p> <p>Please note:</p> <ul style="list-style-type: none"> • We reserve the right to offer places to children whom we feel can benefit from the broad and varied curriculum offered and make a positive contribution to the School community. • All successful candidates must have the legal right to live and study in the UK or, where appropriate, will be sponsored by the School to do so, subject to meeting UKVI regulations. • It is assumed that a pupil will automatically progress through the School, subject to their meeting the required standards of behaviour and relevant academic criteria at the time.
Offer of a Place	<p>13+ (Year 9) and 14+ (Year 10) Entry Candidates seeking 13+ or 14+ places are provided with unconditional offers as long as they have satisfactorily met the entrance criteria. The School reserves the right to apply additional academic assessments for those candidates who are deemed to be borderline.</p> <p>16+ (Sixth Form/Year 12) Entry Sixth Form offers are conditional upon achieving the entry level grades at GCSE if the candidate is in the GCSE system.</p> <p>To confirm a place at Stowe, a refundable Acceptance Deposit of £1,500 is required. If the family lives outside the UK, an additional deposit of £12,000 is also required.</p>

ASHFOLD SCHOOL, SWANBOURNE HOUSE SCHOOL & WINCHESTER HOUSE SCHOOL ADMISSIONS PROCEDURES & CRITERIA

General	At Ashfold School, Swanbourne House School and Winchester House School we are keen to identify pupils who will benefit from our caring, balanced and well-rounded education and will make a positive contribution towards the life of the school. Pupils wishing to join will undergo familiarisation days and assessments. Pupils may join the school in any year group and in any term, providing there is a space available. Applicants for admission should register as soon as possible. This includes parents registering where other siblings are already in the School. The registration form is available from the Registrar or the School website.
Registration Fee	£150 (excl. VAT) non-refundable Registration Fee.
Procedure	<p>The assessment process is aimed at identifying if a prospective pupil will be able to thrive within our broad and rigorous curriculum and the school is able to cater for the pupil's needs.</p> <p>No specific preparation for the Entrance Tests is required; all candidates start on an equal footing, with identical opportunities to display their academic aptitude.</p>

1. **Nursery (Winchester House)/Pre-Reception (Ashfold School and Swanbourne House)**

Children attend a session in the Nursery/Pre-Reception for observation.

2. **Reception, Year 1 & Year 2**

Assessment for Reception, Year 1 or Year 2 is based on observing prospective pupils within our school environment in small classroom groups and informal play.

3. **Year 3 to Year 4**

Teachers will look at the child's ability to access the curriculum in areas such as spelling, reading and maths, this will be compared to their age group.

4. **Year 5 to Year 8**

Candidates take age-appropriate assessments in English and maths, often as part of normal academic activities, such as CATs, NGRT, PTM, PTE, Salford and SWIST. The assessments are neither selective or competitive and are in line with the normal screening process for all children. They will also have a formal interview with a Senior member of Staff.

For all entry points, we reserve the right to ask children to attend further sessions should a clear picture not be gained during the first session.

Admissions Criteria for Reception and above

1. A positive recommendation from the prospective pupil's present setting (if in education).

2. A satisfactory assessment.

3. A positive attitude to learning and behaviour.

4. The disclosure of confidential information including, but not limited to:

- Any medical condition, health problem or allergy affecting your child.
- Any learning difficulty, disability, or special educational need of your child, as well as any behavioural, emotional and/or social difficulty of your child. This will enable the School to consider any adjustments that it may need to make to assist your child to partake in the School's admissions procedure or when your child enters the School.

We also ask you to disclose any welfare concerns relating to your child that the School should be aware of, including:

- Self-harming behaviour and/or eating disorder.
- Any incidents of bullying.
- Mental Health issues such as ADHD, anxiety, panic attacks, OCD, depression, suicidal thoughts.
- Referrals to Child Social Services and/or Court Orders.

Offer of a Place	<ol style="list-style-type: none"> 1. A child will be offered a place if the assessments show that a Candidate will benefit from the broad and challenging curriculum; is well matched to the learning attitudes and ethos of The Stowe Group and the School can cater to their needs. 2. A child will not be offered a place: <ol style="list-style-type: none"> a. If, in the opinion of the School and supported by corroborating evidence, the child has insufficient skills, particularly in literacy and maths, so as not to be able to manage the demands of the curriculum. b. The child's behaviour and attitude to learning demonstrated during assessment does not meet the School's policy. c. If the School does not have at present, or is unlikely to be in a position to provide in the near future, appropriate equipment and facilities to enable the child to fully access the curriculum and if to do so will prejudice the provision of efficient education or the efficient use of resources. 3. To confirm a school place, a refundable Acceptance Deposit of £1,000 is required.

	Change 100	Change 100 is a bursarial programme open to candidates without the need for a Scholarship. These bursary places are for those who would need 100%+ remission on the School Fees and for whom the opportunity to attend one of our schools would be transformative. 		<p>5% Day</p> <p>Stowe Group Sibling Discounts are awarded when a third sibling joins two other siblings from the same family in any of our Stowe Group of Schools. A 10% fee discount is awarded to the eldest two siblings with all younger siblings within The Group each receiving 5%. The discount for each child is maintained during their time at our schools as long as all siblings remain within The Group until the end of their Stowe career.</p>

These are assessed in the Lent Term of Year 6 and awarded to Internal and External candidates and start in Year 7.</p> <p>Head's Award The Head's Award is a recognition of outstanding talent in Academics, Music, Drama or Sport. These awards are linked to a bursary (please see below section on bursaries) and are awarded at the Head's discretion upon individuals who exhibit exceptional talent, commitment and potential in one or more of the disciplines mentioned above.</p> <p>The Head's Awards are typically offered to pupils entering Year 7 and 8, with the application process commencing in the preceding September while they are in Year 6.</p> <p>To be considered for a Head's Award, the candidate will follow the admissions process, with additional assessment by Staff at the Prep School if applying for a music, drama or sport award. They will also be required to have a meeting with the Head.</p> <p>Successful achievement of a Head's Award does not guarantee subsequent scholarship or bursarial support as pupils progress to their Senior school.</p>

		After registration and on completion of the admissions process, a means tested assessment can be carried out on request, bursaries can be offered in order to make it possible for pupils who meet the School's admission criteria to attend the School. Bursaries are typically offered from Year 6 upwards.

Candidates for admission will be treated equally, irrespective of their, or their parents' or guardians', race, sexual orientation, religion or belief, gender identity or any disability.

Our schools are inclusive and welcome applicants with disabilities and special educational needs. Our schools currently have limited facilities for the disabled but will do all that is reasonable to comply with its legal and moral responsibilities under the Equality Act 2010 and Special Educational Needs and Disability Act 2001 in order to accommodate the needs of applicants who have disabilities for whom, with reasonable adjustments, the School can cater adequately.

Parents/Guardians of a child who has any disability or special educational needs should provide the School with full details on registration. Our schools need to be aware of any particular requirements which may affect a child's ability to participate in the admissions procedure and to take full advantage of the education provided at the School.

The School shall determine the reasonable adjustments that are required for the applicant based on the information provided, in accordance with the School's obligations under equality legislation. The School will consult with parents about the adjustments which can reasonably be made to ensure that the application procedure is accessible for the child and that the School can cater adequately for the child should an offer of a place be made.

Each school's decision on whether it can cater adequately for a candidates needs by making reasonable adjustments depends on: whether the adjustment will remove the substantial disadvantage; the cost of the proposed adjustment; the resources available internally or from external providers; the practicability of making the adjustment; health and safety requirements; the interests of other pupils including those who may be admitted to the school; and the school's charging structure generally.

APPENDIX A

Nursery at Ashfold School

As an Ofsted registered early years provider, Ashfold School is legally bound to meet the requirements of the Ofsted regulations and the Early Years Foundation Stage Framework published by the Department for Education.

The core hours offered for Nursery:

Monday to Friday, 34 weeks of the year (term time only) are as follows:

- [Breakfast Club Session](#) 7.30am-8.15am*
- Morning Session 8.15am-12.45pm (including lunch)
- Afternoon Session 12.30pm-3.30pm
- [After-school Club](#) runs until 4.25pm or 5.15pm on Mondays, Tuesdays, Thursdays and Fridays.
- [After-school Club](#) runs until 4.25pm or 5pm on Wednesdays.

*Note Breakfast Club and After-school Club are not available for rising 3-year-olds.

Eligibility

- Non funded places are available, once the child is three years old.
- Funded Entitlement places are available the term after the child's third birthday.

Criteria for admitting children into Nursery in addition to the admissions policy, will be prioritised based on:

- Children requiring full time places, in order of application.
- Siblings of children already at Ashfold School or within The Stowe Group.
- Siblings of children joining Ashfold School in the same academic year.
- Children requiring morning sessions.

For children requiring part time places, priority will be given to requests for the higher number of sessions.

- Parents may access funded-only hours in the afternoon session - 12:30pm–3:30pm, Monday to Friday, term time only (34 weeks per year)
- The maximum of 15 funded hours per week can be accessed at Ashfold. Where fewer hours are used, the remainder may be accessed at another setting.
- Consumables, meals and snacks during funded hours are chargeable items and will be communicated and agreed in advance with parents and clearly itemised. There are no mealtime allocations within the funded hours and there is no expectation for children to take up any chargeable meal, snack or consumable. If parents opted for their child to receive a snack in the funded hours, the expected cost would not exceed £1 per day a snack was taken.
- Outings and trips are outside funded hours and will be clearly communicated and require parental agreement.
- Where parents are unwilling or unable to pay for any of these additional charges then the basic funded care will continue to be provided at no detriment to the children.

- Deposits will be refunded within 6 weeks of the child starting for funded hourly places and on leaving the school for non-funded places.
- One 'stand-alone' place per academic year is available for one child accessing only their Funded Entitlement hours.
- Priority will be given to Stowe Group employees and subsequently siblings of children already at Ashfold School or within the Stowe Group or joining Ashfold School in the same academic year.
- With the exception of the one 'stand-alone' place available per academic year, all other children must register for a minimum of seven sessions per week.

Funded Entitlement

Funded Entitlement is not intended to cover the cost of meals, other consumables, additional hours or additional activities.
